Per Concord Development Ordinance Article 4.5, no person shall perform land-disturbing activities that cause or contribute to the violation of a water quality standard or property damage resulting from the improper control of sedimentation and erosion. All developments shall control sedimentation and erosion and minimize the negative impacts of sedimentation and erosion on water quality and property.

If conducting *any* land-disturbing activity of one acre or more, an erosion control permit is required before beginning the disturbance. This includes the disturbance of multiple lots totaling one acre or more. Sites greater than one acre are also subject to State Permit #NCG010000 and required to maintain self-inspection logbooks.

Failure to maintain Erosion & Sedimentation Control measures may result in penalties.
