Dear Fellow Melrose Drive SW Neighbor and Homeowners:

My name is Audrey Balknight Allison and I reside at 165 Melrose Drive SW. I am writing you today to make you aware of my petition to the City of Concord to rename a portion of "Melrose Drive SW" to "Balknight Drive SW" (outlined on the enclosed map).

My reason for contacting you is because you own a home within the affected portion of the road which would result in a minor change to the street address. Additionally, I would like to share the driving force behind my request.

My father, Kenneth Balknight, Sr., purchased the majority of the land on the fore mentioned portion of Melrose Drive SW "roughly" 50 years or so ago. I grew up in the family house on this road, along with my parents and five siblings. I have many fond memories of joy, laughter, fun, good times and bad times. Most of all, I can remember the pride my dad exhibited not only in the upkeep of our land, but also the beautification and cleanliness of the entire stretch that bordered our land, city-owned and all. Over the years, my father sold the farthest end portions of the land, closest to Melba Court and Robbins Street (some of you purchased from him). However, the middle portions have always remained "Balknight" property. Fast forward to today...my parents are both deceased and my siblings have all since moved to their own respective homes, still within the Concord area. I married and moved to New Jersey where I resided for 20 years. After my husband passed unexpectedly in 2012, I returned to Concord and reclaimed residence in the family home in 2016. I was surprised and saddened to see the conditions (litter and debris) of the roadsides, banks and ditches that my father had taken such pride in maintaining while he was alive and able. I took it upon myself to clean up what parts I could and contacted the city for what was beyond my means. This is what brings me to where I am today...petitioning the city to rename the road.

My brother and I continue to own the vast majority of the land on this segment of Melrose Drive SW. In memory of my dad, my intent is to "adopt" this stretch of the road and pledge to help the city in maintaining the cleanliness and upkeep of the roadsides and ditches that are within my means, just as my father had done in the past. With the adoption of the road, I would like to have it renamed as a reflection of the pride my father had (and my family continues to have) in the neighborhood and community in which he lived.

As a valued neighbor and resident of the affected portion of Melrose Drive SW, I am asking for your support as I petition the city to change the street name in memory of my father (Kenneth Balknight, Sr.), by signing the enclosed statement and returning it in the self-addressed stamped envelope by Monday, March 11, 2019.
